

Draft Resolution – Empowering my path Block

Topic: Situation of the minor irregular migrants

The United Nations Children's Fund:

Recalling that all parties to armed conflict must keep the Convention on the Rights of the Child and its Optional Protocol on the involvement of Children in armed conflict, as well as the Geneva Conventions of 12 August 1949, and their Additional Protocols of 1977, the Cape Town Principles and Paris Principles,

Recognizing that the actual number of displaced people is the highest ever recorded in history,

Recalling its Resolution of 12 February 1946, in which it proclaimed that the problem of refugees and displaced persons was international in scope and nature,

Bearing in mind the Universal Declaration of Human Rights proclaimed by the General Assembly of the United Nations on 10th December 1948,

Affirming the articles 2, 3 and 14 of the previously stated declaration,

Expressing its appreciation for the Convention on the Status of Refugees made in Geneva in July 1951, as amended by the New York Protocol of January 31, 1967, and also reaffirming its great importance for the international protection of refugees,

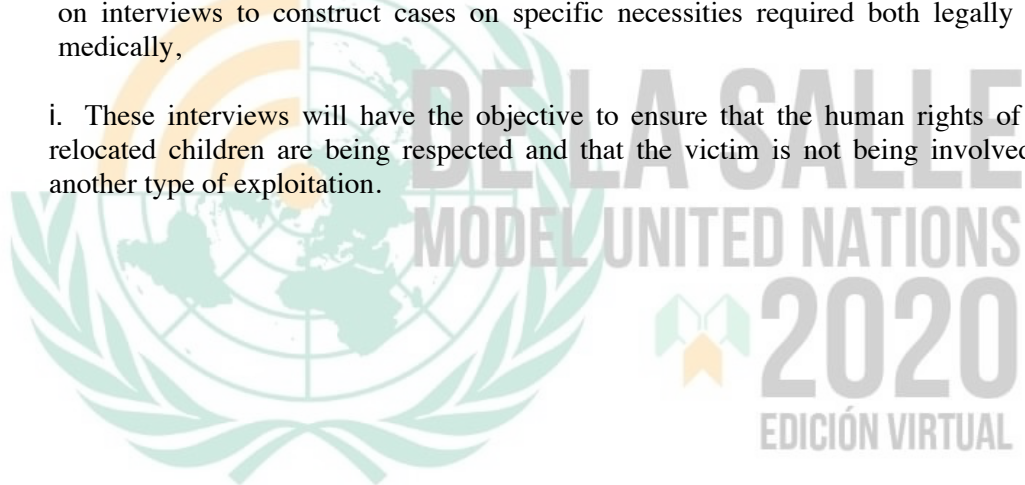
1. Further recommends the creation of the SPD (Safety, Participation and Documentation) program with safety and support, working with the United Nations High Commissioner for Refugees (UNHCR) and Save the Children (SCF), the Gandhi National Memorial Society and the Confederation of Voluntary Agencies and Development initiative (DAJI), Group for the Convention for the rights of the child, ECPAT International, among other Third Party Actors, to be applied in source, transit and recipient countries, including established communities and refugee camps with help of the implementation of the "Safe Home" Program, through:

a. Safety: Taking into consideration the Executive Committee No 105 on Women and girls in Risk,

i. Regarding the update presented by El Pais, prevention of sexual abuse and sexual violence by implementing education policies in schools and communities, in accordance to as set the proposal of implementing Route Breakers Task Forces and with help of the respective Ministry of Human Rights with help of the United Nations on Drugs and Crime (UNODC) Human Trafficking and Migrant Trafficking Section (HTMSS) specialists,

ii. Prevention of sexual harm, creating awareness with chats in the refugee's communities involving minors, about the different forms of abuse (either verbal or physical) against

- children and teenagers, regarding the Convention on the Protection of sexual Abuse and the UN Declaration of Children Rights,
- iii. Codes of conduct and staff training for teachers, police and community leaders; also train volunteers who work with children and come from the different organizations and countries, after a series of tests to assure its capacity to work with minors,
 - iv. Increase awareness of sexual abuse or violence related to cultural practices, such as FGM through communal meetings;
2. Promotes the implementation of the “Safe Home” Program, working together with the SPD programme in conjoint action with the UN Habitat Cities and domestic Migration Offices, local and regional governments to promote the allocation of trafficked children in local citizens houses, to ease the prosecution process while contributing to the reinsertion of victims, funded by the IOMs Development Fund, and the #YoCamino Campaign from the IOM, through:
- a. The creation of a regional database in cooperation with UNICEFs Data and Analytics Department and the States’ Interior Ministry officials, managed by IOMs Global Migration Data Analysis, focused on gathering data regarding current trafficked and smuggled children and viable foster housing options as well as collecting information on interviews to construct cases on specific necessities required both legally and medically,
 - i. These interviews will have the objective to ensure that the human rights of the relocated children are being respected and that the victim is not being involved in another type of exploitation.
